2) House Bill 7055: Many items rolled into one Includes scholarship programs Changes to charter school laws Changes to Title 1 funds and how they are used Changes to how tax dollars are able to be spent Best and Brightest - includes those who are not in the classroom but are still employed by the school system Changes to Teachers' Unions - 50% membership rule to recertify

It will be a huge year for legislative voting.



36 members of the Constitutional Revision Commission have been meeting to plan amendments. 8 proposed amendments are being placed on the ballot, in addition to 5 others. Those 8 are bundled amendments.

Civic literacy will be proposed, as well as term limits for school board members. Also, another change proposes that charters be established by authorizers other than school boards. 60% is required for amendments to be passed.
