## Mill Creek Extended Day Program 2020/2021

### Pick-Up and Drop-Off

All PM Care students must be picked up and signed out by an authorized adult. Any changes to authorized pick-ups should be made prior to pick-up time. \*\*A photo ID is required at time of pick-up.\*\*

\*\*\*All AM Care students must be walked into the café and signed in by an adult. No Exceptions.\*\*\*

#### **Behavior**

Your child is expected to follow the same rules and use the same behavior as they would during the school day. We use a three strike policy. Upon receiving a third strike your child will be removed from the program. There may be circumstances that arise which may result in immediate dismissal from the program.

### **Transportation Changes**

Please notify the school as well as Extended Day if there are changes and the student will not be attending Extended Day that afternoon. Transportation changes should be emailed to the front office at mcatransportation@stjohns.k12.fl.us.

### **Payment of Services**

Please make all checks payable to MCA-Extended Day. Make sure to put your child's name under memo and your phone number must be on the check. Payments may also be made online at www.schoolpay.com.

There are no refunds once fees are paid.

Due to Florida Law, all fees must be paid prior to services rendered. Therefore, your child may not attend the Extended Day program until the fees for that period have been paid in full. Please see our Payment Schedule for due dates.

#### **Termination of Services**

We request a 2 week notification if you are pulling your child out of the program. Remember, there are no refunds once payments have been made and processed.

## Mill Creek Extended Day Program 2020-2021

Registration Fee of \$80.00 is due prior to starting in the program.

Prior to Start—Payment due for August 31—September 24. (Payment must be made prior to start) September 14th, 2020—Payment due for September 25—October 20. (Sep. 21st late fee added) October 7th, 2020—Payment due for October 21—November 17. (Oct, 14th late fee added) November 3rd, 2020—Payment due for November 18—December 16. (Nov. 10th late fee added) December 3rd, 2020—Payment due for December 17—January 26. (Dec. 10th late fee added) January 12th, 2020—Payment due for January 27—February 23. (Jan. 20th late fee added) February 10th, 2021—Payment due for February 24—March 24. (Feb. 18th late fee added)

March 9th, 2021—Payment due for March 25—April 21. (Mar. 23rd late fee added)

April 13th, 2021—Payment due for April 22—May 17. (Apr. 20th late fee added)

May 7th, 2021—Payment due for May 18—June 10. (May 14th late fee added)

#### **See Schedule of Fees**

All fees are due prior to service. There are no exceptions.

Payments can be made online at www.schoolpay.com.

Make all checks payable to MCA Extended Day and put the child's name in the memo line. The district also requests that all checks have two phone numbers to contact if there are any issues with payment.

Late payments will be charged \$25.00 after 5 school days past the due date.

While we do not foresee any price changes, all fees are subject to district approval. Changes may be necessary to meet district requirements.

PM Care—1:45PM—6:00PM—Wednesday
2:45PM—6:00PM—Monday, Tuesday, Thursday and Friday

**PM Care closes at 6:00PM.** Parents are responsible for picking up their child on time. In case of an emergency alternate pick-up arrangements should be made. **You will be charged a \$1.00 per minute late fee payable at time of pick-up.** This is to offset the cost of having a staff member stay past their contracted hours.

If there is an emergency and you will be late please call me at 904-501-1514.
